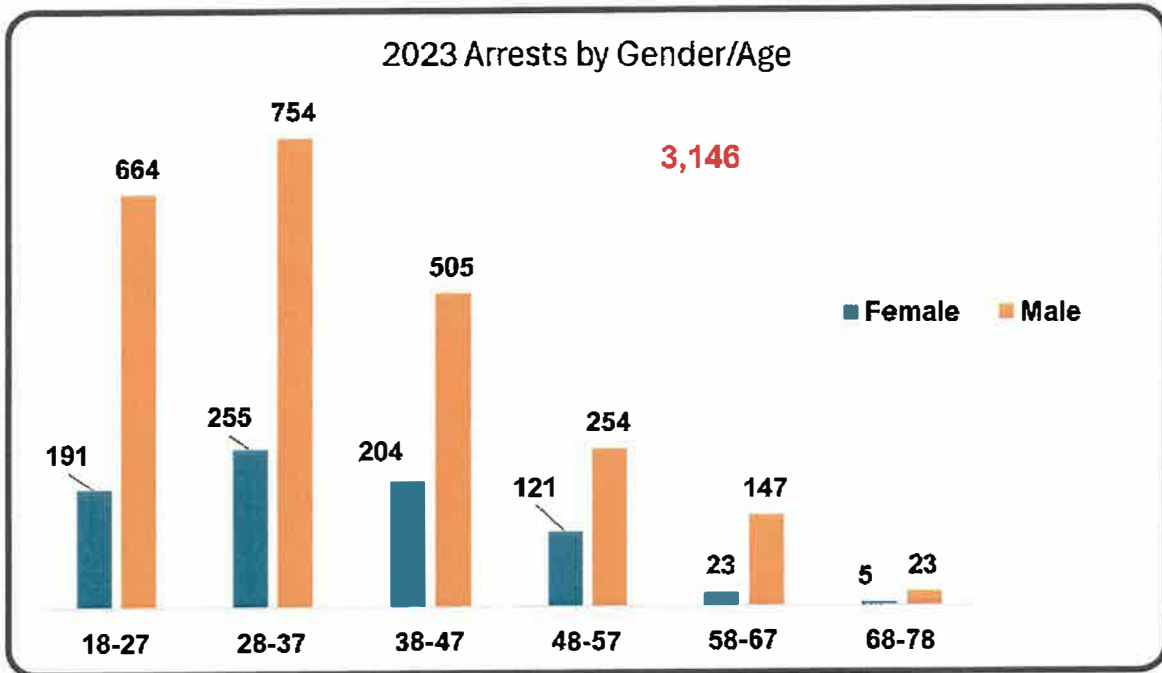

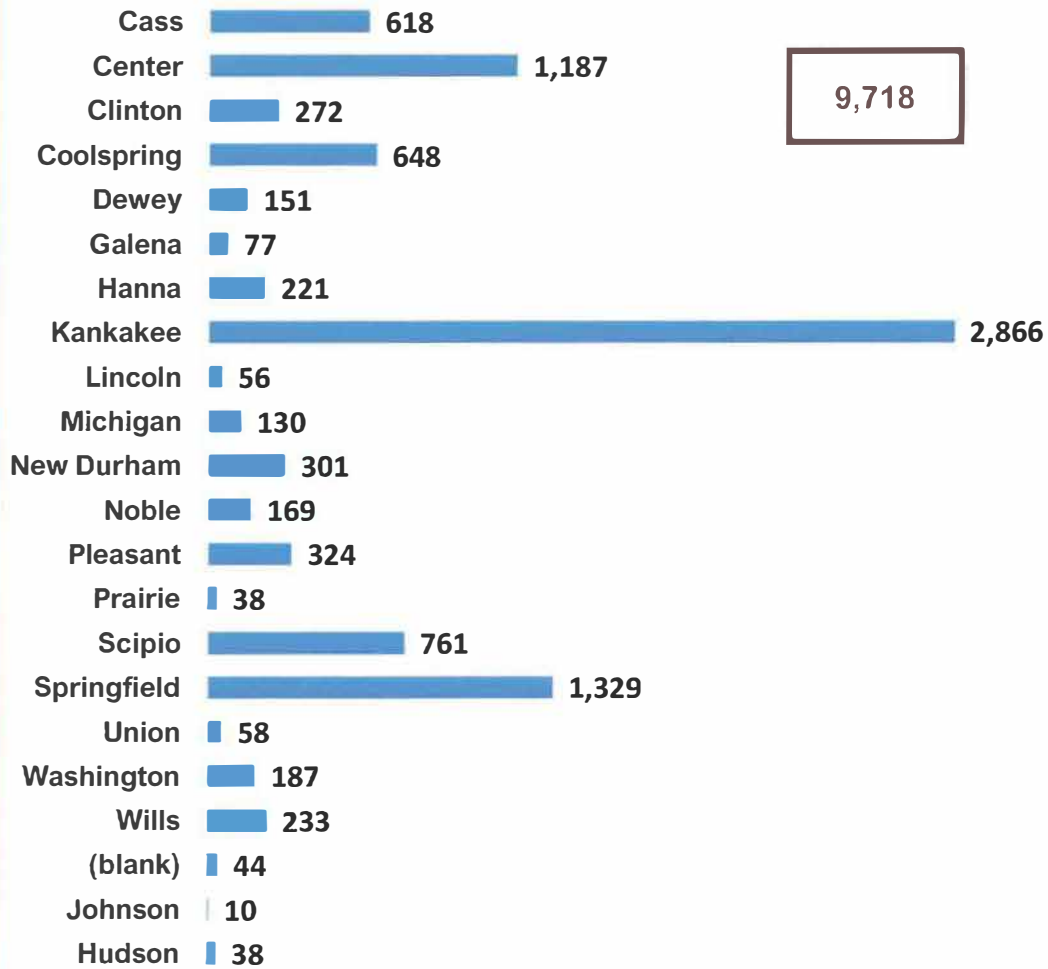

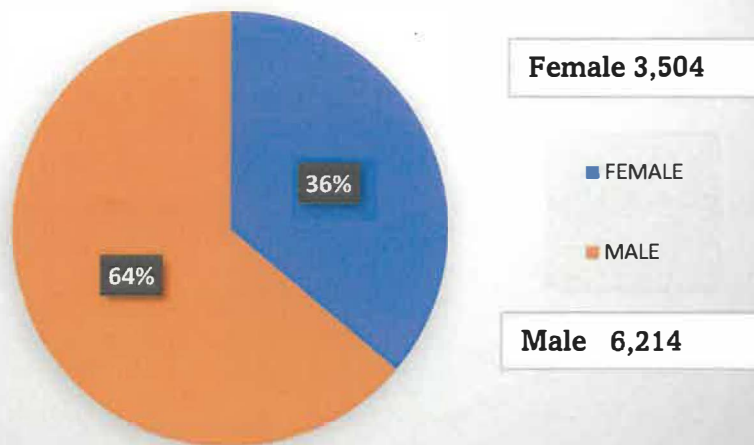
2023 Citations by Township



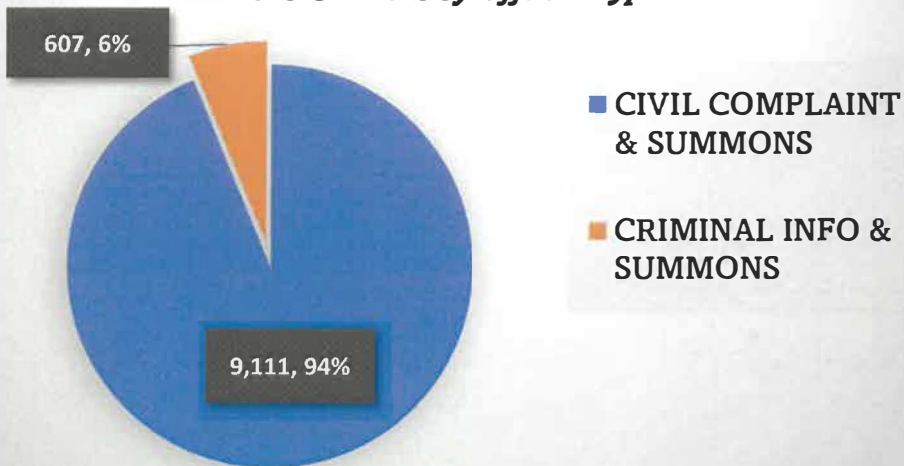
2023 Traffic Tickets and Warnings

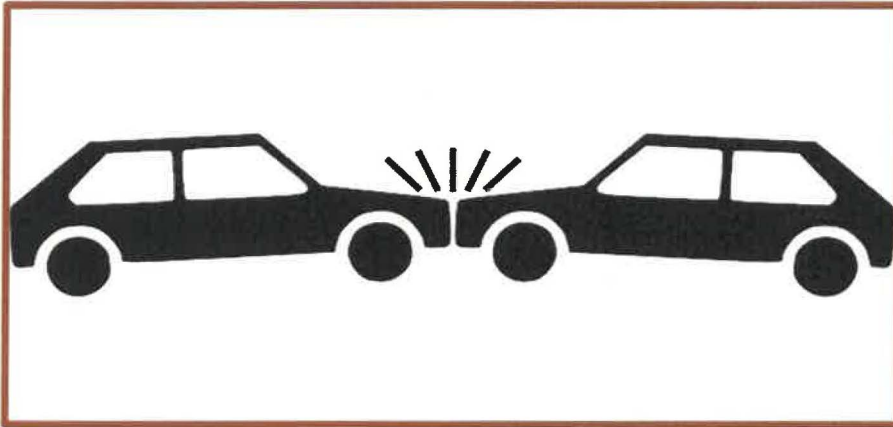

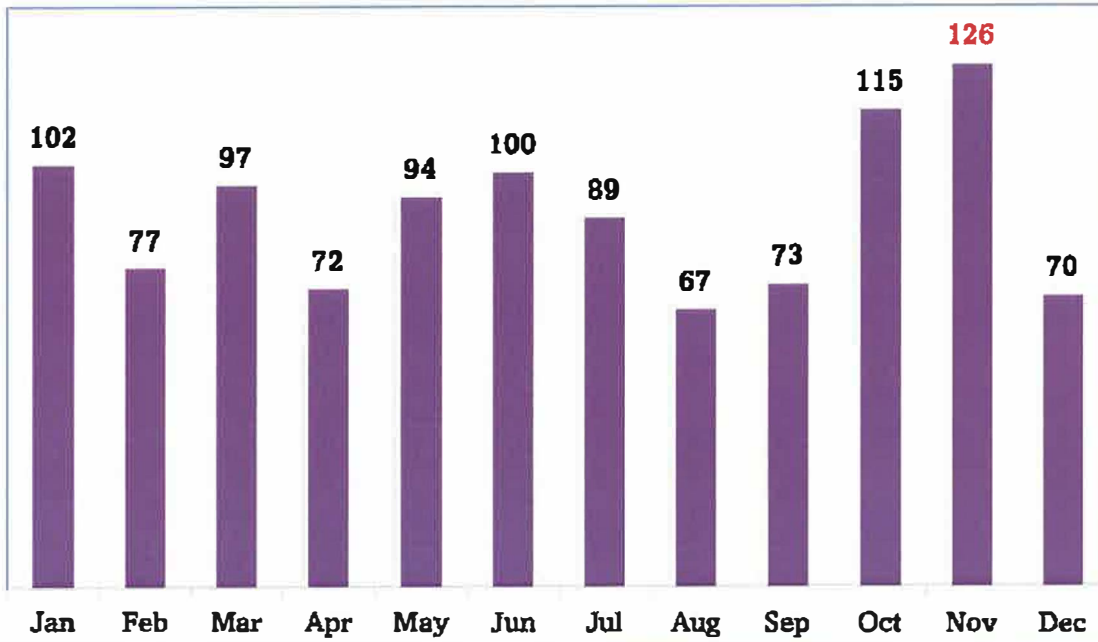

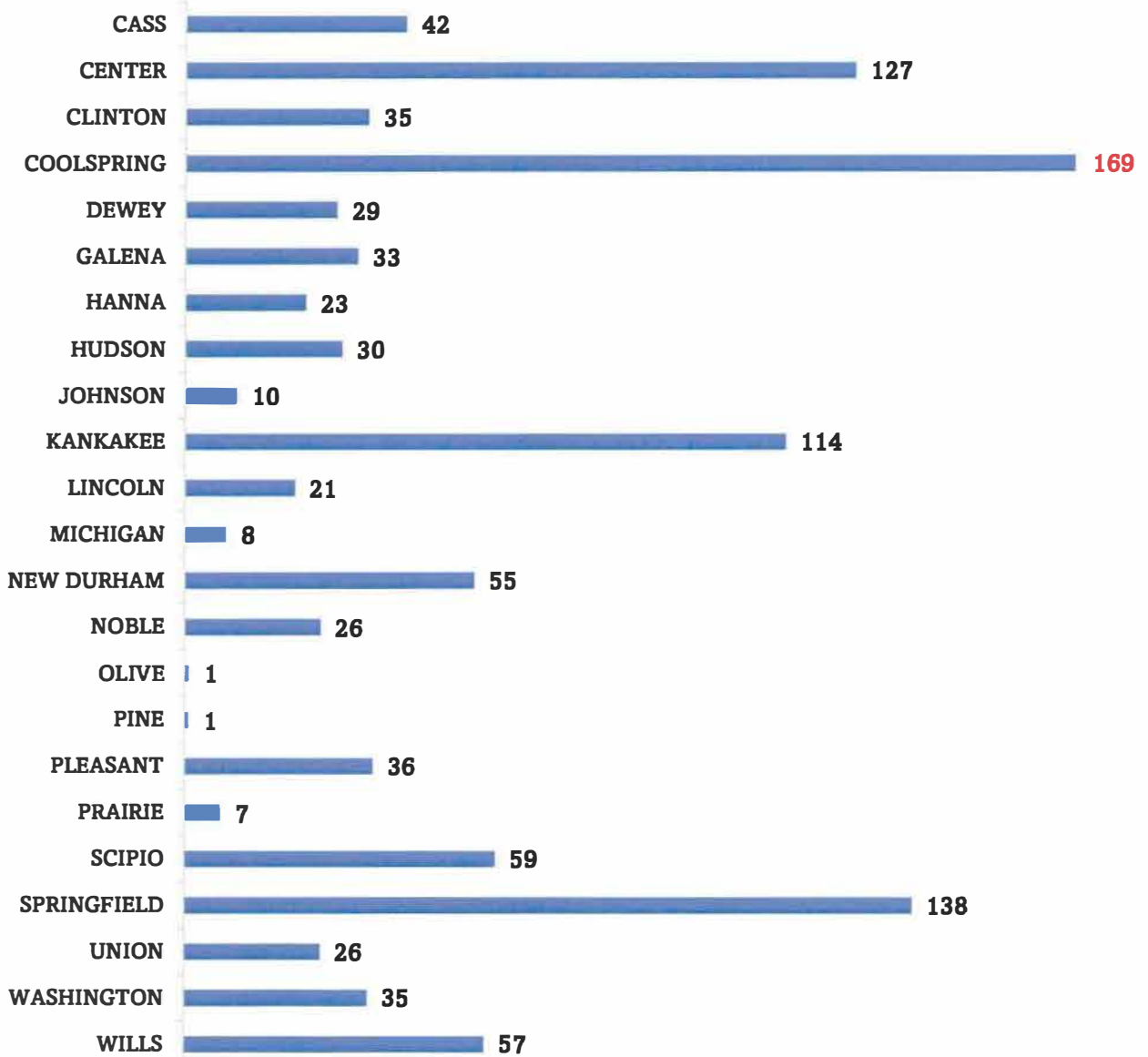


2023 Crash totals by Month



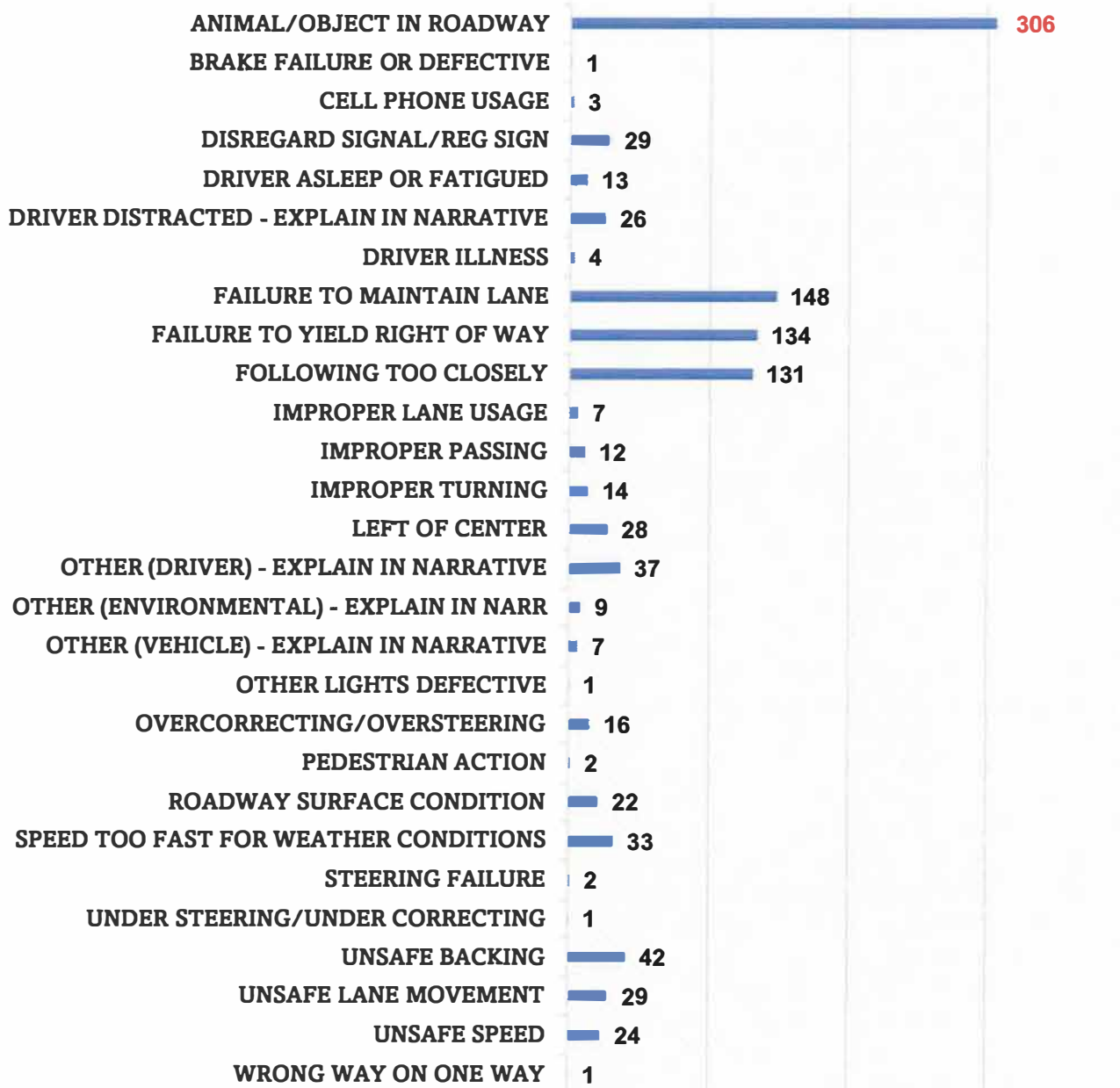


2023 Crash totals by Township

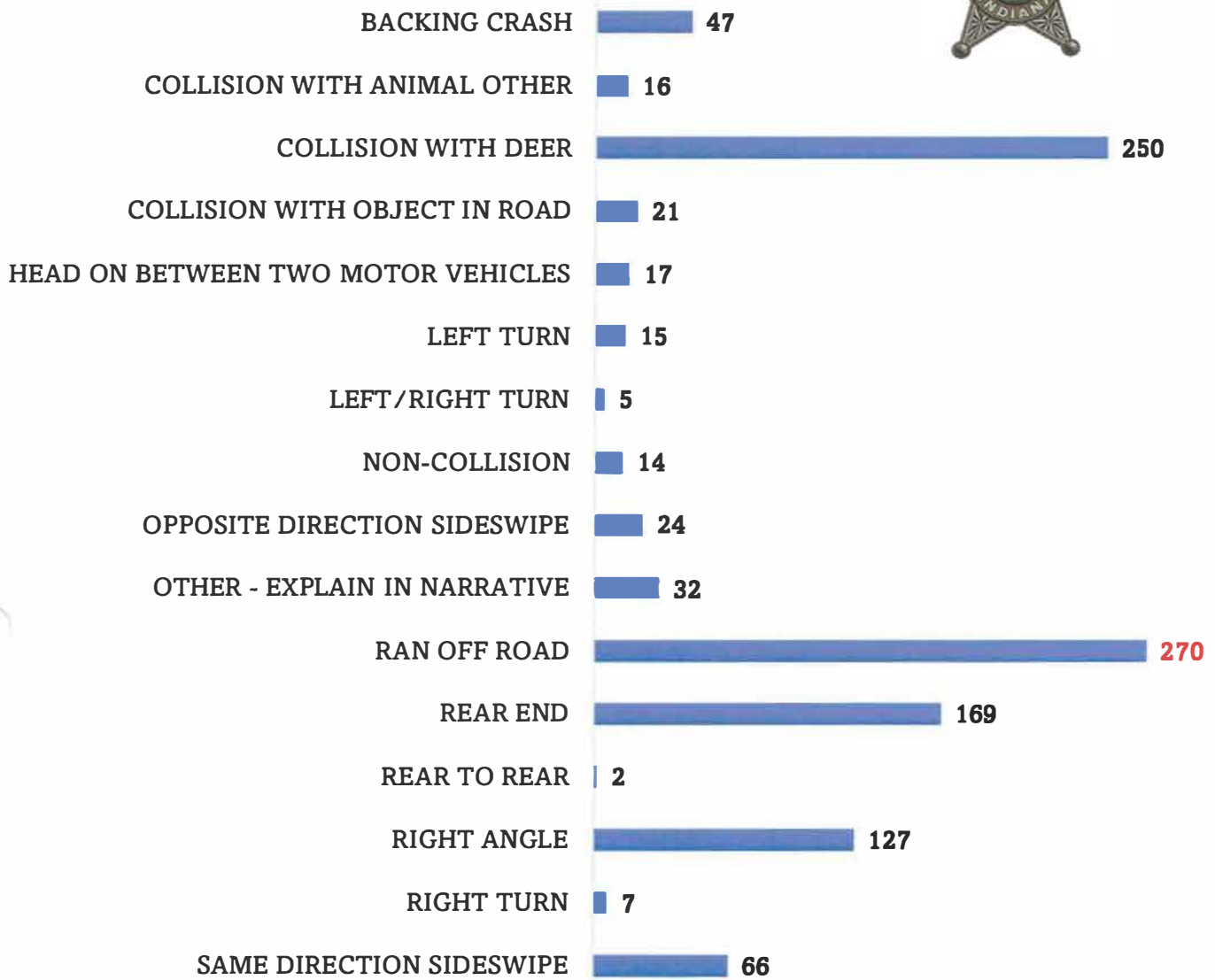




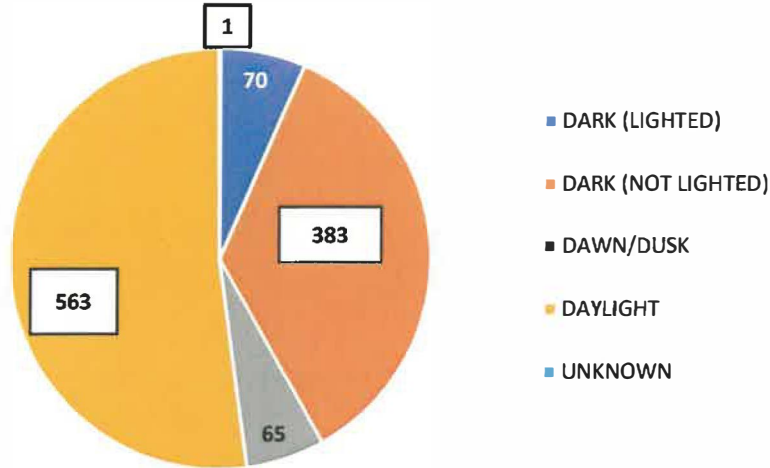
2023 Crash by Primary Factor



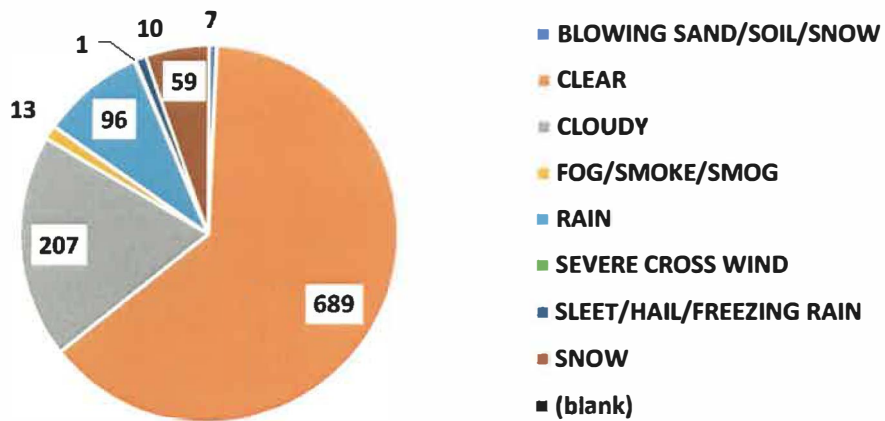
2023 Crashes by Manner of Collision



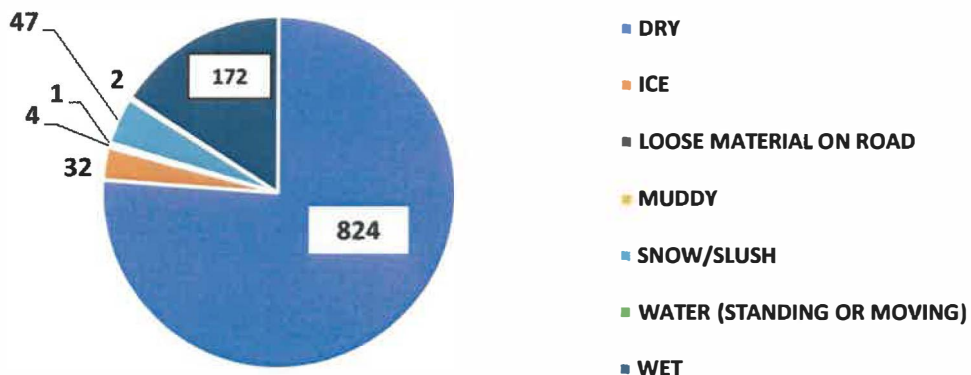
Crashes by Light Condition

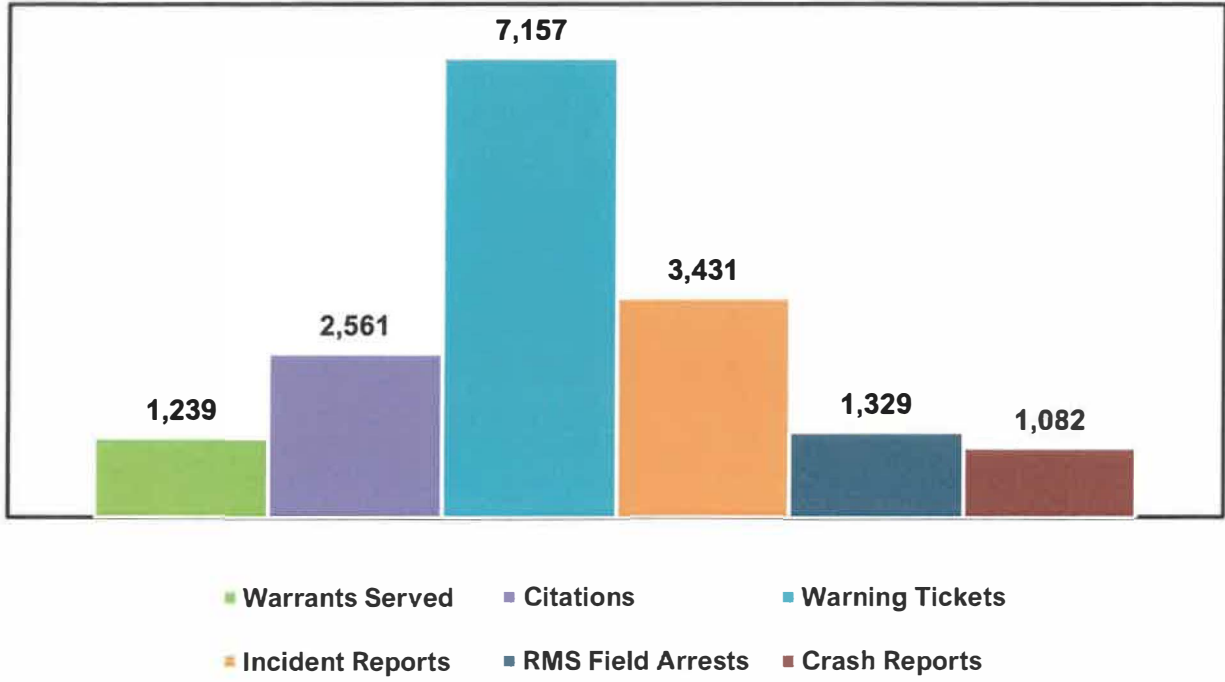
